

Simple development finance for Scottish housing

Allia's Scottish charitable bond programme provides flexible loans for housing associations, supporting the vital development of affordable housing across Scotland.

To date, Scottish Government has invested almost £70m in Allia Scottish charitable bonds, resulting in 14 loans for 10 housing associations. These are expected to provide over 900 new affordable homes. The loans are unsecured, with simple and straightforward terms, for up to 10 years – and it's only at the end of the term when the loan and interest needs to be repaid.

The added bonus is that any interest on the loans is re-used by Scottish Government to create a grant fund, so they can donate funds to further support housing development – which helps keep the money in the sector you work in. So far almost £20m has been donated, a real positive boost that couldn't be achieved through other finance options.

Here's what some of the housing associations we've helped have said:

Ayrshire Housing

Ayrshire Housing is one of Ayrshire's leading housing associations with over 1,500 houses.

The £1.6m loan in 2016 enabled Ayrshire Housing to build 22 new affordable and energy-efficient homes for their community.



Hjaltland Housing Association

Hjaltland Housing Association aim to provide high-quality housing for tenants throughout Shetland.

The loan of £1.3m they received in 2017 has helped them on their way to reaching their new home target, by enabling them to build 31 new homes in Tingwall, Scalloway and Lerwick.

Lochaber Housing Association

Lochaber Housing Association was set up in 1988 as a response to the chronic housing need in Lochaber’s rural communities.

With a £2m loan in 2016, they have built 62 affordable homes, bringing significant benefits to the area.
