

Impact milestones over the last 25 years

2022


We open a Future Business Centre in the Guildhall, central Cambridge, and expand the King's Hedges site to include a second building to create our Cambridge Campus.

2024 - Allia turns 25!

We celebrate arranging and advising on over £4 billion of financing, supporting 520 tenants across our buildings and over 4,039 entrepreneurs to Start and Grow their business.

2017

We expand into London, with offices in East London where we run venture support programmes.



2015

We launch Serious Impact, free support programmes for entrepreneurs. These evolved into the successful suite of support programmes we run today.

2015

We open a new Future Business Centre in Peterborough, based in the Peterborough United Football Club stadium. We have supported 177 tenants and 1,011 ventures from this centre.

2015

Retail Charity Bonds (RCB) is launched – a new platform designed to make it affordable for charitable organisations to raise unsecured finance through bonds listed on the London Stock Exchange. To date, £397 million of bonds have been issued for 8 charities.



2014

Our Scottish charitable bond programme is set up in partnership with the Scottish Government to provide loans and grants for building affordable and social housing. Over £480 million has been loaned to date, and more than £124 million of grant funding has been awarded.

Allia leads Social Incubator East, a programme for social ventures. In 2016, it becomes part of the Cambridge Judge Business School

We open our first Future Business Centre in Cambridge, Kings Hedges Road. We have supported 202 tenants and 1,207 ventures from our Cambridge Campus.

We change our name from Citylife to Allia.

Scottish Charitable Bonds

Home Scotland received a £15 million loan, arranged by Allia C&C through the Charitable Bond programme funded by the Scottish Government.

The loan will help Home Scotland deliver just under 900 homes across the country over the next five years, which include a mix of social rent and mid-market rent.

The Charitable Bond programme provides simple, unsecured loans to housing associations for up to 15 years, while the interest paid over the life of the loan funds a grant programme for social housing subsidies. Since the programme started in 2014, the Scottish Government has invested over £480 million in charitable bonds with the Allia Group.

We're delighted to have secured the loan from Allia. The funding will support the delivery of our development programme across Scotland. It's also great to see that the interest we pay on the loan will be used to fund more social rented homes.

RCB Bonds The Alnwick Garden Trust

Allia C&C arranged the issue of £18 million of bonds through RCB for The Alnwick Garden Trust in 2020 to finance the construction of Lilidorei, the world's largest play structure and village.

Allia C&C acted as the financial advisor to YMCA St Paul's Group, on the restructuring of its debt portfolio and the negotiation of a new debt facility.

The outcome is a simplified operating structure, reduced running costs and a more efficient debt portfolio with a new lender, a longer average life and covenants suited to the needs and aspirations of YMCA St Paul's.

We are very pleased with the outcome of our reorganisation, after which we will operate through a single company with an optimised debt portfolio and covenant package. This leaves us in a strong position to continue to deliver exceptional social impact to our communities and improve the lives of young people facing homelessness.

The central location, impact-driven ethos, sense of community and friendly centre team are why we enjoy being tenants.





Our Impact Accelerators and Accelerator Challenges are for later stage start-ups ready to scale. We have worked with a wide range of partners, including the Mayor of London, Balderton Capital and DIF Capital Partners, who provide expertise and funding opportunities.

Funding

We work with value-aligned organisations to offer funding to help businesses grow and create more impact. We offer a wide range of funding instruments, including grants, loans, revenue participation agreements and equity investments.

Special Projects

Allia Future Homes

Allia Future Homes helps tackle homelessness by building affordable, sustainable "supported modular housing communities". With the UK homelessness crisis intensifying, these supported communities and other extra transitional housing will be vital to give as many people as possible their own front door keys.

Since 2020, we have led the development of 12 new homes in two successful Cambridge and Wisbech communities. A further 20 homes have since been built in Cambridge, inspired by our work. Our 2024 project will add another 24 homes, delivering a caring community of safe, energy-efficient, and cost-effective housing.

Over the next three years, Allia Future Homes aims to lead projects to deliver at least 10 more communities totaling 60+ extra homes. Supporting also a wider addition of 250 more such homes through knowledge-sharing and partnerships.



AgeTech

The AgeTech project focuses on creating innovative solutions to address the challenges of ageing populations. It integrates advanced technologies, such as AI and robotics, to enhance the quality of life for older adults.

The project's key areas include improving healthcare, facilitating independent living, and fostering social inclusion. It aims to develop smart systems for eldercare, offering personalised assistance, monitoring health, and ensuring safety. By leveraging cutting-edge tech, the AgeTech project seeks to empower older people, reduce the strain on caregivers, and create sustainable, age-friendly environments that support healthy and dignified ageing.

The Future


All of Allia's financing, buildings and programmes in our first 25 years have been united by a common focus to catalyse and amplify the impact of other social ventures.
